PPGJS NOTICE No. 02/2024

Universidade Federal Fluminense (UFF) hereby announces that applications for the Master's Degree in Justice and Security of the Programa de Pos-Graduação em Justiça e Segurança (PPGJS) [Graduate Program in Justice and Security] of the Instituto de Estudos Comparados em Administração de Conflitos (InEAC) [Institute of Comparative Studies in Conflict Management] will be open from **July 24th to September 13th, 2024**. Two vacancies will be offered to foreign candidates, with one place reserved for refugees or holders of humanitarian visas or asylum seekers.

The selection process will be conducted remotely.

The selection will be carried out from **September 25th to October 7th, 2024**, according to the schedule set out in this Notice.

It is important to note that the Master's Degree in Justice and Security (stricto sensu course) is taught in person.

Program Objectives:

Master's Degree in Justice and Security at PPGJS/UFF is an academic course, in the in person format, which aims to train professionals who, with rigorous academic training, are focused not only on working in the university market, but also on using and disseminating their knowledge for the benefit of the existing market within other institutions such as, for example, non-governmental organizations and public administration in general.

Master's degree classes require full-time, in-person dedication from the beginning of the course in March 2025, even without obtaining a scholarship. It is important to note that the PPGJS does not guarantee scholarships and, as it is a relatively recent program, the number of scholarships available is very limited.

1. Introduction

The Board of the Graduate Program in Justice and Security PPGJS/UFF use of their legal

and regulatory attributions, decides to establish vacancies, criteria for registration, selection and admission of 02 foreign students, with a reserve of 01 vacancy for refugees or humanitarian visa holders or asylum seekers for the PPGJS/UFF Master's Course in the form below.

1. Vacancies.

- 1.1. For this selection, PPGJS/UFF offers a total of 02 (two) vacancies for master's degrees, 01 (one) for reserving vacancy for candidate refugee or humanitarian visa holders or asylum seekers.
- 1.2. It will not be mandatory to fill all available vacancies.
- 1.3. The PPGJS does not guarantee scholarships.

2. On the Application

Applications for this selection process for the Academic Master's course of the Programa de Pós-Graduação em Justiça e Segurança, for the Academic Period of 2025, must be executed exclusively through the e-mail pjs.iac@id.uff.br - Subject: Notice for Foreign Candidates - from July 24th to September 13th, 2024.

- 2.1. It may apply graduates with a degree obtained from any undergraduate course.
- 2.2. At the time of application, applicants must send, within the period indicated, the following documents in PDF format, in high resolution, one file for each document:
- 2.2.1. Application form (Annex III)
- 2.2.2. Copy of the official **identity** card (RNE, passport or asylum application protocol in Brazil);
- 2.2.3. Cover letter written by the candidate, expressing his/her motivation for this Master's course and his/her availability of time and financial means to complete the course.
- 2.2.4. Preliminary project written by the candidate him/herself and it must have up to 8 pages (including the quoted bibliographic references and footnotes), typed with 1.5 spacing, on A4 paper, in Times New Roman font, size 12; it must not include a cover page. Files that do not meet these specifications will not be considered. Preliminary project must include, in addition to the applicant's name: 1) Title; 2) Proposed research topic; 3) Relevance of the study to be developed in the Programa de Pós-Graduação em Justiça e Segurança and in the chosen Line of Research; 4) Objectives; 5) Methodology; 6) Basic bibliography for the chosen topic; and 7) The indication of the names of three professors (see Annex III) that would be their advisor in order of preference (first, second and third option).
- 2.2.5. **Lattes CV** (available for filling at https://lattes.cnpq.br/), with a copy of publications, if the candidate has one.

- 2.2.6. Copy of the **Diploma** (front and back). If it is not issued in Portuguese, English, Spanish or French, it is fundamental to be translated into Portuguese; and recognized by an official entity, in accordance with decision no. 219/2001 and resolution no. 18/2002, which provides for the acceptance of degrees obtained abroad for the purpose of continuing studies at UFF.
 - 2.3. Will have their applications approved by the Selection Committee only applicants who submit, within the deadline and in the manner established, the required documentation set out in item 3.2 of this Notice.
 - 2.4. The candidate, when submitting the required documentation exclusively electronically, is responsible for the veracity of all information provided.
 - 2.5. There will be no enrollment or monthly fees charged.
 - 2.6. The final result will be made public on the PPGJS website http://ppgjs.uff.br/ and/or e-mail provided by the applicant on the application form until October 7th 2024.

3. On the Selection

- 3.1. The first stage of the selection process consists of the review by the examining board of the cover letter, the pre-project and the curriculum, which will be analyzed considering their suitability to the PPGJS profile (See Annexes I and II).
- 3.2. The second stage of the selection process consists of a translation test into Portuguese of a text in Spanish, French or English. The translation test will be sent to the email address provided by the candidate in the application form on September 25th, 2024. The test must be sent to the PPGJS on September 26th, 2024 via email: pjs.iac@id.uff.br
- 1.1. For any clarifications by the examining board regarding the pre-project, CV, cover letter and/or translation test, the candidate may be interviewed remotely, from September 30, 2024 to October 4th, 2024. The date and time of the interview will be sent to the candidate via email provided in their application form up to 48 hours in advance.

4. On Filing of Appeals and Results

- 4.1. Applicant's final classification will be announced by September 18th, 2024, through the email address filled in the application form by applicants and published on the PPGJS/UFF website (https://ppgjs.uff.br/ingresso-2/).
- 4.2. Applicants may appeal regarding the results of the approval or rejection of applications by sending an email to: pjs.iac@id.uff.br, on September 19th, 2024, until 6 pm.
- 4.3. The final result of applications will be made public on the PPGJS website http://ppgjs.uff.br/ and/or e-mail provided by the applicant on the application form until September 23th 2024.

5. On the Final Provisions

5.1. Concurrent enrollment in more than one stricto sensu graduate course at UFF will not be

permitted.

- 5.2. The PPGJS will issue a Letter of Acceptance to the candidate approved in the selection process, with a view to obtaining a student visa and other legal purposes.
- 5.3. By registering for the selection process, the candidate acknowledges and unconditionally accepts the rules established in this Notice as well as the PPGJS regulations and the UFF rules regarding graduate studies.
- 5.4. It will be responsibility of Board of the Programa de Pós-Graduação em Justiça e Segurança of Universidade Federal Fluminense (PPGJS/UFF) for resolving cases not covered by this Notice.
